

The below requirements must be met for successful completion of the PGY1 pharmacy residency.

Requirement
1. Obtain license as a registered pharmacist in the State of Missouri within 120 days of the start of residency
2. Obtain medication therapy services (MTS) certification through the Missouri Board of Pharmacy within 120 days of the start of residency
3. Complete all rotations
<ul style="list-style-type: none"> a. Orientation b. Administration c. Drug information/drug policy development d. Internal medicine 1 e. Critical care f. Infectious diseases (general) or antimicrobial stewardship g. Internal medicine 2 or transitions of care (TOC) h. Four electives i. CLOPS (code coverage, level 2, on-call, presentations, staffing, self-evaluation) j. Committee work (longitudinal) k. Research project (longitudinal) l. Resident Education Academy (longitudinal)
4. Achieve a minimum of 90% of the required objectives for PGY1 pharmacy residencies
5. Complete all assigned PharmAcademic evaluations
6. Obtain or hold an active certification from the American Heart Association (AHA) as an Advanced Cardiovascular Life Support (ACLS) Provider
7. Prepare and present a drug monograph or class review to an appropriate subcommittee of BJC/BJH P&T
8. Complete all service commitment requirements of the residency program
<ul style="list-style-type: none"> a. Scheduled staffing shifts as delineated on the weeknight staffing shift schedule (minimum of 40 shifts per residency year) b. Scheduled staffing shifts as delineated on the holiday staffing shift schedule (minimum of one holiday shift per residency year) c. Scheduled staffing shifts as delineated on the weekend staffing schedule (minimum of 10 weekend shifts per residency year) d. Scheduled on-call shifts as delineated on the on-call schedule (minimum of four on-call shifts per residency year) e. Scheduled code coverage as delineated on the code coverage schedule (minimum of four weeks per residency year)
9. Complete at least one resident research project
<ul style="list-style-type: none"> a. Preparation and presentation of a research project handout for the Gateway College of Clinical Pharmacy (GCCP) resident research roundtable b. Preparation and presentation of research project defense PowerPoint for the BJH clinical pharmacy specialist group c. Preparation and presentation of a scientific poster for the Vizient poster session during the ASHP Midyear Clinical Meeting d. Preparation and presentation of research project overview and results PowerPoint for the Midwest Pharmacy Residency Conference e. Preparation and presentation of research project overview and results to a subcommittee of BJH P&T f. A manuscript suitable for publication written and submitted to the RPD
10. Complete all required non-research related presentations
<ul style="list-style-type: none"> a. Preparation and presentation of one formal seminar PowerPoint at the University of Health Sciences & Pharmacy (UHSP) resident seminar series b. Preparation and presentation of a minimum of three formal case/journal club presentations for the BJH clinical pharmacy specialist group c. Preparation and presentation of a minimum of two informal case/journal club presentations for the BJH clinical pharmacy specialist group
